## The Patient Safety (Notifiable Incidents and Open Disclosure) Bill 2019

The Patient Safety Bill which makes provisions for mandatory Open Disclosure of notifiable incidents (as listed within the bill) passed the final stage in the Dail on the 15th February 2023. The bill is currently at Report stage in the Seanad and will progress soon to final stage before it is enacted. Please note that the title of the bill has now changed to the **Patient Safety (Notifiable Incidents and Open Disclosure) Bill 2019**. The HSE has commenced work on an implementation plan to support the roll out of the bill across all HSE and HSE funded health and social care services.

The National Open Disclosure Office will inform you of any further updates/ progress and will plan further training, including e-learning and a webinar, on this legislation during 2023.

## Department Of Health National Open Disclosure Policy Framework

The National Open Disclosure Framework which provides overarching principles and a national consistent approach to Open Disclosure across all health and social care services in Ireland (public and private) is due to be published in the coming weeks.

The Framework guides the operational procedures and standards which determine how patients/service users, their families, or support persons and carers are communicated when something goes wrong in the course of their care. The Framework leads relevant health and social care services providers through the substantial culture change required to improve patient/service user outcomes and experience in this area. The Framework also recognises and guides developments in the substantial education and learning changes required to enable these improvements.

The HSE National Open Disclosure Policy will be further revised to ensure alignment with the Framework. Going forward the Framework requires that all health services providers provide an Annual Report on the implementation of the HSE Open Disclosure Policy. Further guidance on this will be provided by our office going forward. An implementation tool has been developed to support services in assessing compliance with the policy and is currently being tested across a number of service areas.

## Open Disclosure 2022 Annual Training Report – Mandatory Training

The Open Disclosure Annual Training Report for 2022 is now published on the HSE website. Access it [here](#). This reports provides an update on training per service delivery area for 2022 while also providing cumulative three year data.

Open Disclosure training is mandatory for all staff working in the HSE and HSE funded services. All staff must complete Open Disclosure e-learning Module 1 "Communicating Effectively through Open Disclosure"

Staff who may be involved in formal open disclosure meetings must also complete:

- E-learning Module 2 "Open Disclosure: Applying Principles to Practice" and
- Module 3 Face to Face Skills Workshop (3 hours) on the management of the open disclosure process.

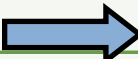

## Share the Learning

In line with the HSE Patient Safety Strategy, the open disclosure programme is committed to using and sharing information to ensure learning to improve good practice and patient safety. The 2022 Open Disclosure Annual Report includes a section on “Share the Learning” which focuses on the management of multiple disclosures i.e. when a patient safety incident involves more than one patient /service user. The National Open Disclosure Office collated feedback received from a number of staff who have been involved in the management of multiple disclosures. The learning that was shared from this focuses on:

- Preparation and planning for multiple disclosure meetings
- Managing open disclosure meetings
- Supports and Resources to assist the management of multiple disclosures
- Additional comments and recommendations
