The Nursing Homes Inspection Team visited Sacred Heart Nursing Home on 1<sup>st</sup> November 2006.

There were 21 residents on this date. The Nursing Home is currently registered for 23 residents.

The following issues require your attention and action.

Article: 19.1 (e) Register & Record. Medical record with relevant details, duly signed

and dated by medical practitioner.

Issue: The current recycled medical stationary does not allow the proper

manipulation of the medical files to support the above.

Required Action: The purchase of new medical file stationary that will permit proper

organisation of medical information.

Timescale: As agreed as soon as possible.

Recommendations: This ought to include, for example, a pocket to hold correspondence

safely, mount sheets for blood tests and investigation results and a

supply of continuation sheets into the future.

Article: 7.1 Contract of care within two months of admission to nursing home.

Issue: One resident is in the process of being made a ward of court since

admission on 3<sup>rd</sup> February 2006 with a letter on file dating from then

from her solicitor.

Required action: Write to the solicitor to enquire about the progress of the ward of court

status. A copy of this letter to remain on file in the nursing home.

Timescale: Immediately

Recommendations: For ease of administration a separate lever arch file containing all

current contracts of care should be commenced.

Article: 7.3 Contract deals with the care and welfare and include details of services

to be provided and fees to be charged.

Issue: One contract of care is missing the fees to be charged.

Required action: This omission is to be amended.

Timescale: Immediately.

Recommendations: A copy to be forwarded to the nursing home office.

Article: 20 Confidentiality of records, maintenance of confidentiality

Article: 29 (a) Arrangements for recording, safekeeping, administration and disposal

of medicines.

Issue: The sharing of the filing cabinet between medical files and the drug

Compliance system blister packs due to limitation of space is one which

needs to be addressed.

Required action: As agreed the future planned extension of the nursing office must allow

A separate lockable medical filing cabinet and a lockable drug trolley.

Timescale: As soon as is practical in keeping with new extension planned.

Article: 11.2 (j) Emergency call facilities.

Required Action: The emergency call bell at the vacant bed in room 2 was not working.

Recommendations: The call bell shall be repaired.

Article: 11.2 (g) Appropriate bedding, furniture, fixtures and fittings.

Require action: The mattress in room 1 is torn and shall be replaced. New bed linen

shall be provided as most of the linen was worn and see through.

Article: 11.2 (g) Provision of suitable and sufficient furniture.

Required action: The existing bedside unit in Room 14 is unsuitable. Any furniture which

Is no longer in good repair shall be replaced.

Recommendations: Replace this unit with a suitable locker. Replace all broken and

worn furniture.

Article: 14 (a)	State of repair, cleanliness and hygiene.	
Required action:	All areas of the nursing home shall be thoroughly cleaned on a regular basis. Cleaning staff shall be employed for longer periods to ensure all areas are covered.	
Recommendations:	Documented cleaning programmes shall be produced and Implemented throughout the home detailing cleaning duties, frequencies etc.	
Article: 15 (a)	Hand washing facilities.	
Required action:	The mixer tap at the wash hand basin in the shower room only gave a supply of cold water.	
Recommendations:	A supply of hot and cold water shall be available at the wash hand basin at all times.	
Article: 12 (a)	Design.	
Required action:	All fixtures and fittings shall be maintained in a safe condition.	
Recommendations:	The leaking toilet in the assisted bathroom shall be repaired.
