Dear Doctor / Pharmacist,

The Health Service Executive (HSE) faces an unprecedented challenge in the current financial environment to deliver services in a way that will minimise any adverse impact on patients and continue to protect as far as possible, our most vulnerable citizens. To do this we need to reduce costs and continue to harness efficiencies within the Primary Care Schemes.

As you know the Health Service consumes over €5 billion in goods and services each year and the drugs bill, in particular, has increased at an unsustainable rate in the past decade. We must make savings over and above what has already been achieved in recent years. This year we have additionally included for reimbursement a number of innovative therapies, for example, Ipilimumab, Boceprevir and Telaprevir, which are of demonstrable benefit to patients.

You may already be aware that a number of products, such as Glucosamine, have been identified both nationally and internationally as not cost effective or of lesser benefit to patients. A recent study, claiming to be one of the largest and longest trials of the supplement, concludes that Glucosamine neither alleviates pain nor disability and that "glucosamine probably offers little benefit…beyond whatever placebo effect it may provide."

We are conscious of our responsibilities as laid down in Section 7(1) of the Health Act 2004 i.e. "....to use the resources available ... in the most beneficial, effective and efficient manner to improve, promote and protect the health and welfare of the public." Accordingly, the HSE is suspending the reimbursement of the following range of products from the List of Reimbursable Items with immediate effect: Glucosamine; Gluten Free Products; Orlistat; Omega-3-Triglycerides. A Supplemental Update of the GMS Code Numbers affected is attached for your information.

The HSE will not reimburse for any prescription for this range of products under the Primary Care Schemes with immediate effect until further notice.
