Dear Ophthalmologist,

Regulations were introduced by the Minister for Health, with the consent of the Minister for Public Expenditure and Reform on 24th July 2013 to reduce payments to Ophthalmologists in respect of certain services rendered to or on behalf of the Health Service Executive under the Community Medical Ophthalmic Services Scheme and the Community Ophthalmic Services Medical Treatment Scheme. In accordance with section 9 (3) of the FEMPI Act 2009, the Regulations are effective from the 24th July 2013. A copy of the Regulations is attached.

I must advise that these reduced payments were not applied at the time. The HSE has sought clarification from the Department of Health on the SI 274 and have been advised to proceed with applying the 3% reduction to Ophthalmologist's fees with effect from date of signature of SI 274. On that basis I wish to draw your attention to Schedule 1 in respect of Eye Examination by Ophthalmologist and Medical Eye Examination by Ophthalmologist and also Schedule 3.

I would draw your attention to the provisions of section 9 (8) of the Financial Emergency Measures in the Public Interest Act, 2009. Section 9 (8) allows a contracting Ophthalmologist who does not wish to continue to render services on behalf of the HSE on the basis of the new payment arrangements to withdraw his/her services if he/she so wish, following 30 days written notice of his/her intention to do so. In any such event, Section 9 (9) of the Act allows the HSE to engage the services of another professional to ensure that services continue to be available.

The Primary Care Reimbursement Service will implement the fee changes and apply to payments becoming due in November 2016 and separately, will review payments made to you in respect of such claims from 24th July 2013 to 31st October 2016 and will be in touch with you in relation to the outcome of the review and to discuss the options going forward.

HEALTH PROFESSIONALS (REDUCTION OF PAYMENTS TO OPHTHALMOLOGISTS, OPTOMETRISTS AND DISPENSING OPTICIANS) REGULATIONS 2013

HEALTH PROFESSIONALS (REDUCTION OF PAYMENTS TO OPHTHALMOLOGISTS, OPTOMETRISTS AND DISPENSING OPTICIANS) REGULATIONS 2013

I, JAMES REILLY, Minister for Health, in exercise of the powers conferred on me by section 9 of the Financial Emergency Measures in the Public Interest Act 2009 (No. 5 of 2009) (as adapted by the Health and Children (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 219 of 2011)), having complied with subsections (4), (7) and (13) of that section, with the consent of the Minister for Public Expenditure and Reform, hereby make the following regulations:

1. These Regulations may be cited as the Health Professionals (Reduction of Payments to Ophthalmologists, Optometrists and Dispensing Opticians) Regulations 2013.

2. In these Regulations—

"residential setting" means any of the following:

- (*a*) a nursing home within the meaning of section 2 of the Health (Nursing Homes) Act 1990 (No. 23 of 1990);
- (b) a home, centre or institution or a part of a home, centre or institution at which residential services are provided to—
 - (i) persons with disabilities, in relation to their disabilities, or
 - (ii) other dependent persons, in relation to their dependencies,

by the Health Service Executive, a person who enters into an arrangement under section 38 of the Health Act 2004 (No. 42 of 2004) to provide a health or personal social service on behalf of the Health Service Executive or a person who receives assistance under section 39 of the Health Act 2004;

(c) a centre within the meaning of section 62 of the Mental Health Act 2001 (No. 25 of 2001);

"disability" means disability as defined in section 2 of the Disability Act 2005 (No. 14 of 2005) and the term "substantial restriction" in that definition shall be construed as meaning a restriction as described in paragraphs (a) and (b) of section 7(2) of that Act.

3. These Regulations shall apply to payments in respect of-

- (a) services rendered by an ophthalmologist, optometrist or dispensing optician to or on behalf of the Health Service Executive under the Community Optometric Services Scheme, the Community Spectacle Dispensing Services Scheme and the Health Amendment Act Card Scheme, and
- (b) services rendered by an ophthalmologist to or on behalf of the Health Service Executive under the Community Medical Ophthalmic Services Scheme and the Community Ophthalmic Services Medical Treatment Scheme.

4. The amount of a payment that shall be made to an ophthalmologist, optometrist or dispensing optician in respect of a service referred to in Regulation 3 from the date of the making of these Regulations shall be those specified in Schedules 1, 2, 3 and 4.

- 5. The following regulations are hereby revoked, namely:
 - (a) the Health Professionals (Reduction of Payments to Ophthalmologists, Optometrists and Dispensing Opticians) Regulations 2009 (S.I. No. 195 of 2009);
 - (b) the Health Professionals (Reduction of Payments to Optometrists for Certain Services) Regulations 2011 (S.I. No. 261 of 2011).


