The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 53113/19

To ask the Minister for Health the number of home support hours provided in each LHO area to the end of November 2019 or the latest date available; the way in which it compares to the target in each LHO for the same time period; the number of persons on the waiting list for home support hours in each LHO area; and the number waiting zero to three, three to six, six to 12 and more than 12 months in tabular form.

PQ 53114/19

To ask the Minister for Health the number of older persons waiting for home support packages; and the waiting lists for home care packages by CHO and LHO in tabular form at the end of November 2019 or the latest date available.

The 2019 National Service Plan 2019 provides for;

- 17.9m home support hours to be delivered to 53,000 people inclusive of 410,000 hours/550 home support packages funded under the Winter Initiative 2018/2019
- Intensive Home Care Packages delivered to approximately 235 people with approximately 360,000 hours delivered in the full year

The Home Support Service is funded by Government to deliver a volume of service each year as approved in the HSE National Service Plan. It is a non-statutory service and access to the current service is based on assessment of the person's needs by the HSE and having regard to the available resources and the competing demands for the services from those people with assessed needs. There has been a significant increase in funding being made available for the provision of home support services; an increase of circa €140 million since 2014.

Despite the significant level of service provision, the demand for Home Support continues to grow as the population aged over 65 years' increases. All those waiting are assessed and provided with a service, if appropriate, as soon as possible having regard to their assessed needs. In addition, people being discharged from acute hospitals, who are in a position to return home with supports, are prioritised.

€2m additional funding has been allocated under Winter Plan 2019/2020 to support 600 clients off the community Home Support Waiting list and 510 Home Support Packages funded for hospital egress. These additional HSPs are currently being allocated across the CHOs.

Preliminary data currently available reflects the period to the end of October 2019. As of this date, 14,550,922 home support hours were delivered nationally to 51,404 people, an increase of 295,729 hours when compared to the same period in 2018. Also, as of this date, there were 7,881 people waiting for funding for home support. Data in the detailed format requested (i.e. the number waiting zero to three, three to six, six to 12 and more than 12 months) is not currently collated nationally. While the information may be available locally, it would take considerable resources to collate it nationally.

The Department is currently engaged in a detailed process to develop a new stand-alone, statutory scheme for the financing and regulation of home support services. Developing a new statutory scheme will be an important step in ensuring that the system operates in a consistent and fair manner for all those who need home support services. The Sláintecare Implementation Strategy commits to the introduction of the new scheme in 2021.
