Occupational Therapy

It appears that the same information is requested in both PQ 3726/19 and PQ 3729/19.

Please find attached Appendix 4 which shows the number of Occupational Therapy Patients awaiting First Time Assessment at December 2018. The data is shown in tabular form by age category, by time waiting and by LHO Area.

Note that in 2018 the total number of Occupational Therapy patients seen was 356,716.

Note that where there is a zero in a particular field in most instances this means there is nobody on the waiting list for the particular LHO / period of time waiting. However for a small number of data metrics, where there are zeros across a full row for a LHO or CHO Area, in most instances this means the data for a LHO or CHO Area is combined and returned via another LHO or CHO Area. It is also possible that zero figures on waiting lists may be due to data not being returned at a particular point in time or there is no service delivered in a particular LHO Area.

It is important to note that the overall total in the attachments represents the entirety of the waiting lists.
