## PQ 4711/19 Question: To ask the Minister for Health the number of assaults recorded against psychiatric nurses in each of the years 2011 to 2018, in tabular form; and if he will make a statement on the matter. -Louise O'Reilly

Dear Deputy O'Reilly

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The table below outlines the number of reported assaults against all staff, not only psychiatric nurses for the years 2011 to 2018. The National Incident Management System does not allow us to give a breakdown by grade/discipline.

The figures provided with regard to assaults on staff and in particular the significant increase in reporting from 2016-2018, should not be interpreted solely as an actual increase in the occurrence of such incidents. The figures relate to reported incidents and the increase in reporting may be associated with the emergence of quality and safety governance structures/arrangements and associated improvement in reporting practices. The transition from the use of other recording systems to the use of

the NIMS has been incremental, and the use of NIMS has been organisationally mandated in recent years. With increased compliance in terms of reporting we will over time be able to compare longitudinal data in a more meaningful way.

It is crucial that in interpreting the number of incidents reported that we are mindful that 92.96% of such incidents are recorded to have resulted in either Minor/Negligible harm, albeit that strategies should be implemented to reduce the risk of all assaults on staff.
