## PQ 29929/19

'To ask the Minister for Health the funding allocation for providing respite care in 2019; the amount drawn down to date in 2019; if funding will be utilised for providing respite care in CHO2; and if he will make a statement on the matter'.

Dear Deputy Rabbitte,

I refer to PQ 29929/19 uploaded on the PAD System on 4<sup>th</sup> July 2019 and due for response on 23<sup>rd</sup> July 2019 regarding representations that you have made to the Minister for Health concerning 'the funding allocation for providing respite care in 2019; the amount drawn down to date in 2019; if funding will be utilised for providing respite care in CHO2; and if he will make a statement on the matter'. The HSE has been requested to reply directly to you on this matter. I wish to apologise in the first instance for the late response to PQ 29929/19. The following response outlines the position.

Please see table below with the funding allocation for providing respite care in 2019 across CHO 2 and the amount drawn down to 31<sup>st</sup> May in 2019 by agencies in respect of the provision of respite care across the region: -
