The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

Cork Kerry Community Healthcare has a total of 6.9 designated Speech and Language Therapists (SLT), either at staff or senior grade employed in South Lee SLT services. The table below outlines the current service provided however staff are not assigned on a full-time basis to any particular clinic. It is the role of the Head of Discipline to assign the available staffing resource across the catchment area to meet the presenting needs in the most appropriate way.
