Dear Deputy Donnelly,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

## PQ 23908/19

To ask the Minister for Health the number of home support hours being provided in each LHO area to the end of May 2019; the number of persons on the waiting list for home support hours in each LHO area; and the number waiting 0 to 3, 3 to 6, 6 to 12 and 12 months plus, respectively in tabular form

The 2019 National Service Plan 2019 provides for;

- 17.9m home support hours to be delivered to 53,000 people inclusive of 410,000 hours/550 home support packages funded under the Winter Initiative 2018/2019
- Intensive Home Care Packages delivered to approximately 235 people with approximately 360,000 hours delivered in the full year

Preliminary data currently available reflects the period to the end of April 2019. As of this date, 5,661,457 home support hours were delivered nationally while 6,310 people were waiting for funding for their home support service (details per LHO/CHO at Appendix 1 below).

Data in the detailed format requested (i.e. number waiting 0 to 3, 3 to 6, 6 to 12 and more than 12months respectively) is not currently collated nationally. While the information is available locally from client records, it would require considerable resources to gather this information centrally.

The Department is currently engaged in a detailed process to determine what type of home care scheme is best for Ireland. This process will consider the future design of both the funding and regulation systems for these essential services.
