Dear Deputy Adams,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and outline the position as follows.

From January 2018, all home care is now single funded and comes under Home Support and is not divided into Home care packages and Home Help.

Attached is the breakdown for the number of persons in receipt of Home Support each month in the years requested (2018 and to date in 2019). Attached also is the number of hours delivered from 2016 to date in 2019 (PQ 25146/19).
