Note: Data for children given the MMR at junior infant age (either through school or by GP for age equivalent) for 2017/2018 is provisional (in attached excel file). These data were submitted to the HSE Business Information Unit in 2018.

The data for school year 2018/2019 is not yet available and is pending data inputting by the immunisation office staff.

2017/2018 academic year (provisional pending final data analysis)

Provisional data on uptake of MMR for junior infants for the academic year 2017/2018 was 88.5% (provisional and unpublished data pending validation and final data inputting...likely to change)

2018/2019 academic year

Data for the most recent (still current) academic year will not be available until later this year (provisional) or following completion of data entry in all HSE areas in early 2020.

STATEMENT

The MMR uptake among children a 24 months between 2014-2018 averaged 92.6% (range 92.2%-93%). There has been little change over this period of time

The MMR uptake among children at 4-5 years of age (junior infant dose or age equivalent) has ranged between 91.3% to 91.5% for the school years 2013-2016/2017. The data for 2017/2018 has not yet been finalised and are depended on data inputting. Provisional data for 2017/2018 November 2018 was 88.5%.

The target uptake for both the first and 2nd dose of MMR is 95%. This target has not been meet at a national level although some LHOs have achieved it.
