"To ask the Minister for Health the number of respite hours provided for adults with an intellectual disability in Galway city and county in each of the years from 2008 to 2018 in tabular form and if he will make a statement on the matter".

Dear Deputy Connolly,

I refer to PQ 25960/19 uploaded on the PAD System on 20th June 2019 and due for response on 4th July 2019 regarding representations that you have made to the Minister for Health concerning "the number of respite hours provided for adults with an intellectual disability in Galway city and county in each of the years from 2008 to 2018 in tabular form and if he will make a statement on the matter' The HSE has been requested to reply directly to you on this matter. The following response outlines the position.

I wish to advise you that in 2008 to 2014 the National Key Performance Indicator (KPIs) data collected in respect of respite was categorized as follows:-

- (a) The number of bed nights in residential centre based respite services used by people with an intellectual disability and or autism.
- (b) The number of people with an intellectual disability and or autism benefiting from residential based respite services.

In this regard, the table below details the people's respite provided from 2008 to 2014 inclusive. Please note the significant drop in bed nights from 2011 is primarily a reflection of the change from residential centre based respite model to a home sharing model of respite.
