To ask the Minister for Health the figures in relation to a service (details supplied) in County Donegal; and if he will make a statement on the matter.

Dear Deputy McConalogue

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

Please see below responses to your questions regarding Donegal Home Support Services.

- Donegal Home Support Services comprises of clinical, managerial and administrative staff, as well as Home Help Workers who make up the substantial majority of staff resources. There are approximately 493 Home Help Workers and 28 clinical, management and administrative staff across all of the designated PHN areas in the county.
- 2) County Donegal has currently in the region of 2,000 clients. This number is fluid and will alter on a daily basis. Currently as a county, Donegal Home Support Services maintains more than twice the national average of older persons at home as opposed to long-term care options. This is managed by substantial individual care packages. Although older persons (aged 65+) make up the significant majority of these clients, it also includes services across child and adult disability, palliative care and people aged under 65 with early onset dementia.

- 3) As of July 1, 2019 there are 208 clients approved and waiting a home help service. This equates to 938.75 additional hours per week.
- 4) Recruitment and induction occurs on a continuous basis targeting areas with less capacity and emerging need. A worker is generally appointed in their own locality as work becomes available. Not all successful candidates when approached accept the job and recruitment in some pockets is very challenging.
