The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question's which you submitted to the Minister for Health for response.

Skibbereen Hospital

The project is currently at Stage 2C (Detailed Design & Tender Documentation). Tender drawings & details have been reviewed by HSE Estates and it is hoped that the project will be tendered with the shortlisted contractors in the coming weeks. The project is currently progressing in line with the requirement to complete these works in advance of Jan 1st 2022.

Kinsale Hospital

The project is currently at revised Stage 2A (Scheme Design) which is now complete and has been reviewed by HSE Estates. Construction phasing plans have been agreed and signed off by the Service. The design team are due to commence Stage 2B/2C (Statutory Approvals) in the coming weeks, following a review of the design proposals with the Service, and the project will then advance to a planning application.


Castletownbere Hospital

The project is currently at Stage 2C (Detailed Design & Tender Documentation). Tender drawings & details were reviewed by HSE Estates and the project has been tendered. Tenders were returned and are currently being evaluated. The project is currently progressing in line with the requirement to complete these works in advance of Jan 1st 2022.

Dunmanway Hospital

The project is currently at Stage 4 (Construction). A contractor has been identified via a tender process and a contract awarded. A start date in March has been agreed with the contractor. The project is currently progressing in line with the requirement to complete these works in advance of Jan 1st 2022.
