PQ 19268/19 Question: To ask the Minister for Health the criteria applied when deciding the suitability of a prisoner to be transferred to the Central Mental Hospital if a place is available there; and if he will make a statement on the matter. -James Browne

Dear Deputy Browne,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The Central Mental Admissions policy sets out that all referrals for admission are triaged at an admissions panel meeting on Monday mornings. If a person has a mental disorder as defined in the Mental Health Act or CL(I)A, then triage criteria for placement on the waiting list are applied using the DUNDRUM-1. These guide but do not bind the consultant psychiatrists and clinical director who are obliged to make difficult decisions.

Once on the waiting list, urgency of need for admission is guided by criteria set out in the DUNDRUM-2. Once again, these guide but do not bind the consultant psychiatrists and clinical director who must make difficult decisions.

The clinical principles applied are similar to those used for waiting lists concerning organ transplant, where need exceeds supply or resources. The waiting list for admission to the CMH is problematic. The opening of the new CMH in 2020 will go some way towards alleviating this problem, though demand continues to grow.

For convenience, I have attached the handbook of the DUNDRUM toolkit which contains the DUNDRUM-1 and DUNDRUM-2. Also attached are validation papers from Ireland, and from England, Belgium and Canada. The DUNDRUM toolkit has been translated into Flemish / Dutch, French and is being translated into German. This approach is recognised as useful and valid under circumstances of shortage in other jurisdictions.
