Dear Deputy O'Loughlin,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ 22193/19

To ask the Minister for Health the number of extra home help hours that were provided in 2018 relative to 2017; and if he will make a statement on the matter.

From 1st January 2018, with the approval of the Department of Health, the funding for both the former Home Help Service and the Home Care Package Scheme was combined into a single service, now known as the Home Support Service for Older People.

Since that date, home support activity reflects the total hours and clients across the Home Support Service for Older People, being the totality of the amalgamated former Home Help Service and Home Care Package Scheme. Activity in relation to Intensive Home Care Packages is reflected separately. This new approach has provided significant benefits for the service users, the public and the health system with the services easier to understand overall.

The 2019 National Service Plan 2019 provides for;

- 17.9m home support hours to be delivered to 53,000 people inclusive of 410,000 hours/550 home support packages funded under the Winter Initiative 2018/2019
- Intensive Home Care Packages delivered to approximately 235 people with approximately 360,000 hours delivered in the full year

Table 1 below outlines the number of home help hours & home care packages provided by the HSE for 2017 and the total number of home support hours provided in 2018.

The Department is currently engaged in a detailed process to develop a new stand-alone, statutory scheme for the financing and regulation of home support services.
