Dear Minister Griffin,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Questions, which you submitted to the Minister for Health for response.

There are 46 beds open at West Kerry Community Hospital, with the potential to open a further 8 beds in the future.



While we planned to open a number of additional beds at West Kerry Community Hospital on a phased basis, we have unfortunately faced challenges in recruiting the extra nurses we need. Increasing capacity at West Kerry Community Hospital remains a priority for us, and we continue to make intensive efforts to recruit. The most recent recruitment campaign was last month (September 2019). Every effort has been made to recruit the necessary staff, and we have run three recruitment campaigns in the last year alone. Additional beds cannot open until we recruit the necessary number of staff.

There is no national recruitment embargo or moratorium, there is a priority requirement for all HSE services to maintain, or get to, an affordable staffing level that is sustainable in 2019 and 2020, while also prioritising the delivery of safe services. In light of this, the HSE has introduced control measures relating to staffing and recruitment (including the return of employees on career breaks) to ensure that they live within the available resources provided to them. The control measures in place are not affecting West Kerry Community Hospital as all posts have already been approved. The issue is purely a difficulty in recruiting staff.

We understand the importance of West Kerry Community Hospital to the local community, and excellent care provided by the staff there. We will continue to work to extend the services there.
