PQ 48909/19 - To ask the Minister for Health the number of mental health whole-time equivalents needed as of November 2019 to be recruited for the full implementation of A Vision for Change taking account of demographic changes in each CHO; the teams and specialities in which the additional staff are required by CHO in tabular form; and the estimated full year cost of providing the additional staff - James Browne. -

Dear Deputy Browne

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

As at October 2019 there were 9,932 Whole Time Equivalents [WTE's] employed in the Mental Health Division. A Vision for Change prescribes that the new workforce would comprise approximately 11,000 staff. Based on the increasing population this would equate to 12,354 using 2016 census. Therefore leaving a gap of 2,422 WTE's. The Average Salary including Employers PRSI & Non Pay costs equates to approximately in excess of €80K therefore the cost of implementing VFC staffing levels is approximately €194.8m (this figure excludes cost of services not prescribe in VFC i.e. Central Mental Hospital & Corporate)
