Re: PQ 43038/20 To ask the Minister for Health the numbers of teachers, special needs assistants and classroom assistants who have contracted Covid-19; and if he will make a statement on the matter.

Dear Deputy Boyd Barrett

I refer to the above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response.

This response includes confirmed cases of COVID-19 notified up to 21<sup>st</sup> December 2020. Data were extracted from the Health Protection Surveillance Centre's (HPSC) Computerised Infectious Disease Reporting System (CIDR) on December 30<sup>th</sup> at 9:30 am. CIDR is a dynamic system and case details may be updated at any time. Therefore, the data described here may differ from previously reported data and data reported for the same time period in the future.

**Please note**: Teachers reported to be on career breaks, currently unemployed, retired or on maternity leave were not included in this response. Cleaners, caretakers and kitchen staff were also not included. Other adult cases for whom occupation was not reported, but who were linked to school outbreaks or reported to work in a school, were included in this response. Occupation was not reported for all cases of COVID-19. Therefore the number of cases of COVID-19 in teachers and school staff who were not linked to school outbreaks may be underestimated. This response does not include staff in creches or playschools.

Of the 90,157 confirmed cases of COVID-19 reported between the 1<sup>st</sup> March and 29<sup>st</sup> December:

- 260 cases (0.3% of all cases) worked in schools and were linked to a school outbreak (see table 1 for more detail)
- 292 cases (0.3% of all cases) worked in schools and were linked to an outbreak outside of the school setting at a time when schools were open (see table 1 for more detail).
- 519 cases (0.6% of all cases) worked in schools and were not linked to a school outbreak or any other outbreak but were notified at a time when schools were open (see table 1 for more detail)
- A further 49 cases worked in schools but were notified at a time when schools were closed and were not linked to a school outbreak (see table 2 for more detail).
