To ask the Minister for Health the closures of mental health facilities by county in the past 20 years; and the amount returned from mental health budgets by county to the HSE since 2010.

Deputy Tóibín,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The HSE, and formerly the health boards, have over the last two decades undertaken a reconfiguration to modernise the planning and delivery of all aspects of mental health services for young people and adults. This has been in line with policies such as Planning for the Future and A Vision for Change. Transformation has, essentially, placed greater focus on developing community based services while also upgrading or replacing acute in-patient facilities. In most if not all cases involving closure of a psychiatric/ mental health facility, mental health care was continued and indeed improved through the introduction of alternative care options. The process of closing old institutions has been underpinned by significant additional investment provided for new developments in mental health, particularly over recent years. The closure of individual facilities in the past was also influenced by factors such as concerns arising from inspection reports, and the need to enhance quality and safety overall in line with evolving standards. Examples of institutions that have been closed in the past, and replaced by alternative facilities or new community care options include:

It should also be noted that, in respect of the period highlighted by the Deputy, mental health services were not primarily administered on a county basis, but rather at various times on a health board, Local Health Office or Community Health Organisation basis. In this context, the nature or detail of the financial data requested by the Deputy has not been collated as a matter of routine. Notwithstanding operational changes at local level over the years, funding allocated for mental health has remained within the HSE mental health care group. It would not be realistic, due to various factors such as time and staff resources involved, availability of certain records or addressing more immediate service pressures to provide the information sought in this case. If the Deputy wishes to clarify the purpose and context of his enquiry, he is welcome to contact the HSE directly and every effort will be made to assist with this matter
