Dear Deputy Cullinane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. Your PQ above has been referred to me for response.

Specific Sláintecare Funding was not received by Mental Health and Disability Services; however, Development Funding as set out below was received in the years since Sláintecare was published. The funding relates to initiatives and developments in keeping with the ethos of Sláintecare.

On 19 Aug 2020, the Minister for Health formally approved once off funding of €7.8m to eliminate the backlog of children awaiting assessment of needs that has grown over the last number of years whereby the HSE is now not meeting its statutory obligations under Part 2 of the Disability Act. This will allow for the establishment of Children's Disability Network Teams led service delivery on a proper footing. This is in line with Sláintecare reform and a letter of formal approval is in the process of being issued separately from Slaintecare Division.
