PQ 17878/20: To ask the Minister for Health the number of referrals for all cancers to acute hospitals for Re. the first six months of 2018, 2019 and 2020, respectively; and if he will make a statement on the matter.

**Dear Deputy Cullinane** 

The National Cancer Control Programme (NCCP) tracks electronic GP referrals to Rapid Access Clinics (Breast, Lung, Prostate and pigmented lesion clinics) in the eight cancer centres and the satellite clinic in Letterkenny and holds this data for 2019 and 2020 only. It is important to note that these referrals relate to patients with a suspicion of cancer. Referrals may only be triaged as urgent or non-urgent at hospital level.

The data presented above describes the number of electronic GP referrals sent via Healthlink<sup>1</sup> as opposed to the number of new patients actually attending each of the rapid assessment cancer clinics. Not all GP referrals are made electronically nor is it possible to attribute differences in numbers to actual referrals as the difference may well be due to an increased number of GPs using the system in the timeframe requested rather than an actual increase in referrals. Lastly, it is to be noted that data across all rapid assessment services will be subject to seasonal variation.
