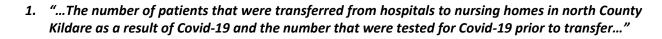
Dear Deputy Cronin.

The Health Service Executive has been requested to reply directly to you in regard to your parliamentary question you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The following Private community long term care facilities in Kildare North are registered and inspected by the Health Information Equality Authority (HIQA).

There is only one HSE community long term care facility in Maynooth, North Kildare.



The National Community Operations Division have stated the HSE arranges the transfer of certain patients from Acute hospitals deemed to be medically fit for discharge, but are not in a position to immediately return to their homes, to a more suitable care setting at a Nursing Home.

Transitional Care Funding is utilised by the HSE to assist in transferring the vast majority of such patients. There are two distinct groups of patients who avail of Transitional Care Funding:

- 1. Patients requiring Long Term Residential Care and who have made a Nursing Home Support (Fair Deal) application;
- 2. Patients who require a period of convalescence care before they return home.

A total of 67 residents were noted having transferred to Nursing Homes in North Kildare during the period March to May 2020 inclusive under Transitional Care Funding.

The Office of the National Director Acute Operations has stated that the HSE or the HPSC do not collect specific data in relation to the testing for Covid-19 prior to transfer.

The Interim Director of the HSE Health Protection Surveillance Centre has advised that they cannot currently comment on the data from private long term care facilities. However we can inform you that the HSE Dublin South, Kildare & West Wicklow Community Healthcare are providing supports to private long term care facilities through our ALERT Crisis Response Team. This Team consists of expertise from the Department of Public Health, Infection Prevention and Control, Consultant Geriatricians, Directors of Nursing and HSE Executives. This team provides supports such as:

- Daily support call to update the HSE on the status of the nursing home in relation to COVID-19.
- Organising for the regular supply of PPE through deliveries via national COVID-19 procurement.
- Providing emergency supplies of Personal Protective Equipment (PPE) where required.
- Linking nursing homes with agency staff where required and available.
- Assisting with sourcing oxygen where required.
- Liaising with the acute hospital frailty teams.
- Linking nursing homes with infection control nurses through public health.
- On call supports over weekend days.
- Infection control webinars and training videos have been made available online.

Our ALERT Team has provided both clinical and staffing support to assist private the long term care facilities during this difficult time. The team is in regular contact with the person in charge of these facilities and will continue to support them and their staff to ensure full care and support is provided to all residents.

We are working to provide solutions to meet the needs of both public and private long term care facilities.

The HSE Maynooth Community long term care facility has recorded 22 COVID-19 positive cases to date since March 2020. Sadly 7 residents died of suspected and confirmed COVID-19 at this facility. RIP. The HSE would like to express its' sincere sympathies to the families and friends of all those who died.



All staff and residents of the Unit have been tested for COVID-19 as part of the testing prioritisation of nursing homes. Currently there are no suspected cases.

All nursing home staff and residents were tested as part of a mass-testing process in April and May. Further mass-testing of all nursing home staff is currently underway as part of a serial-testing process, whereby nursing home staff are tested once per week over a four week period. This process commenced on the 24th of June and is due to continue for circa 5 weeks. Nursing home residents continue to be tested via GP referral (i.e. if they present with symptoms), or on the direction of Public Health (i.e. where there is a confirmed or suspected outbreak in their nursing home). Testing and contact tracing is on-going; testing is based on clinical referral in line with HPSC guidance.

The information that is currently available is number of confirmed positive cases by county and a further breakdown by area.

This data (COVID-19 County Statistics HPSC Ireland Open Data, 2020) is accurate as of 02/07/2020 and is subject to change daily.
