Dear Deputy Ward,

The HSE has been requested to respond to you with regard to your question above.

The HSE completed a review of Pieta House on issues pertaining to challenges that arose during COVID 19 in relation to fundraising and the potential effect on service provision and the request to provide additional funding to the organisation. On this matter, there are some points to highlight;

- Pieta House is an independent Section 39 organisation with a Board of Directors who has responsibility
  to adhere to compliance with the law and support best practice in the governance, management and
  administration as set out by the Charities Regulator, including financial matters.
- The HSE provides approximately 20% of Pieta House's overall funding to provide specific projects/services via a Service Level Agreement (SLA). The process of negotiating and agreeing SLAs with any organisation, includes an ongoing and regular assessment of service activity levels against agreed schedules, and developing an understanding of associated costs, be they anticipated, or unanticipated. Other elements considered during this process include quality and safety, complaints, insurance, spending, performance monitoring, staffing and change control.

structured approach, including developing a modus operandi, providing a methodology for a pro forma

approach for analysis and recommendations to support decision making in respect of Section 39

organisations that have made submissions to the HSE for both financial and non-financial supports

during the Covid-19 pandemic.

• The HSE engaged with Pieta House in this process to ensure, where appropriate, continuity of essential

services as outlined in the current SLA for 2020. The HSE also engaged and communicated with the

Mental Health Division in the Department of Health on the process.

The provision of additional resources to Pieta House is linked to Action 4 of the Government's National

Action Plan which is focused on caring for people who are 'at risk' or vulnerable and outlines the need

to roll out and expand additional supports related to Covid-19. This additional funding is specifically for

the provision of counselling hours for clients deemed to be of high risk. Pieta House has reassured the

HSE that any funding provided will be used for the purposes intended.

It is important to note that additional payments to Pieta House are not due to start until the

Government Scheme ends. The requirement for this additional funding will be reviewed on a monthly

basis by the HSE. The hours that the HSE will be funding (once the payment commences) are a subset of

the level of hours previously provided by Pieta House but funded by voluntary donations, the

availability of which has substantially reduced due to a fall in the fundraising capacity of the

organisation.

The HSE recognises that since the above was agreed with Pieta House, additional fundraising has been achieved

by the organisation. They have also undertaken a review of their services to ensure the financial stability of the

overall organisation and provide a full report to the HSE in July 2020.
