To ask the Minister for Health the wait time for a person seeking the services of the National Counselling Service by HSE area in tabular form.

Dear Deputy Funchion,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The National Counselling Service for adults who have experienced childhood abuse provides counselling and psychotherapy across each HSE Community Health Area

Following referral to the NCS a client is offered an initial assessment appointment to establish if counselling is the most appropriate service to meet their needs. If the NCS is suitable clients are then placed on a waiting list for an ongoing counselling place. The waiting times for an initial assessment in each area are outlined in the Table 1 below.
