The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question which you submitted to the Minister for Health for response.

The table below outlines the cost of Personal Protective Equipment (PPE) provided through HSE national stock to Nursing Homes categorised by CHO. This includes Public, Private and Voluntary Nursing Homes. The items of PPE included in the table below are Hand Gels, Gloves, Goggles, Face Shields, Gowns, Aprons, Protective Suits, Respirator Masks and Surgical Masks.
