PQ 21878/20: To ask the Minister for Health the number of whole-time equivalents by occupation and by directly employed and agency staff, respectively working in the health service; and if he will make a statement on the matter.

Dear Deputy Cullinane,

I refer to your recent parliamentary questions in relation to staffing numbers which was forwarded to the Health Services Executive (HSE) by the Department of Health for direct reply.

Health services employment is reported on a monthly basis through the Health Services Personnel Census (HSPC) which is the official employment count for the public health sector covering the HSE and Section 38 Voluntary Hospitals & Agencies. Information in this response is as per the staff category and staff groupings assigned in HSPC returns with numbers equating to service levels expressed as whole time equivalents (WTE) taking account of part-time working and headcount equating to the number of individuals.

At 31th July 2020, there were 143,672 personnel (equating to 124,490 WTE) directly employed in the provision of Health and Social Care Services by the HSE and the various Section 38 organisations. This represents a WTE increase of 4,673 (+3.9%) over the period 31 December 2019 to 31 July 2020. The latest available details of directly employed personnel by occupational group, as requested by the Deputy, are set out in the following table:

Health service agency staffing resources are collated on the basis of expenditure. Overall agency WTE figures are not centrally collated and therefore are not available. Details for agency expenditure for 2019 together with year-to-date 31st July 2020, as provided by HSE Finance, are as set out in the following table:
