The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

Please see below Table 1 listing the number of staff and testing hours in community testing.

- This calculation is based on each staff member currently operates on the basis of 37.5 hour working week.

The HSE Covid-19 Community Testing Service is committed to the timely provision of safe, accessible, quality swabbing services within the community setting. In order to respond to the pandemic, it was necessary utilise existing staff through redeployment.

The HSE has recently commenced a recruitment campaign for staff to support community testing and tracing facilities for Covid-19. The recruitment of Community Swabbing staff will support the return of Occupational Therapists, Speech and Language therapists and other clinical staff to their substantive roles.

The key document in terms of returning staff to their substantive posts is titled "Service Continuity in a Covid Environment. A Strategic Framework for Delivery".

This framework document was prepared in June 2020 and provides the framework for staff to return to their substantive posts from Covid related work.

The HSE is working to ensure timely access to children and adults requiring therapy services, and to reduce long waiting times for these important services.
