Dear Deputy Lahart,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The Winter Plan 2020/21, as approved by the HSE Board and the Minister, provides for an additional investment of €600m and seeks to support improved patient care in hospitals and in the community while keeping our staff and those who use our services safe in the midst of a global pandemic. One of the key priorities of Winter Planning within the COVID-19 Pandemic is enhancing capacity across the services.

The table below provides confirmed details of the location of the additional rehabilitation beds to be provided under the Winter Plan and also outlines the current start date for the opening of the additional beds at each site. Engagement at local level is continuing to determine specific dates for beds opening with additional rehabilitation capacity under consideration for finalisation in the coming weeks.
