Dear Deputy Smith,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary questions, which were submitted to this department for response.

PQ 19102/21

To ask the Minister for Health the number and name of all private providers of disability residential care for the HSE; and the number of disability residents currently in privately run residential homecare excluding residential nursing homecare for the elderly.

PQ 19103/21

To ask the Minister for Health the estimated full cost of funding to all private providers of disability residential care contracted by the HSE in 2018, 2019 and 2020 excluding nursing homecare for the elderly; and the number and cost of funding and providing services to disability residents in residential care provided directly by the HSE.

HSE Response.

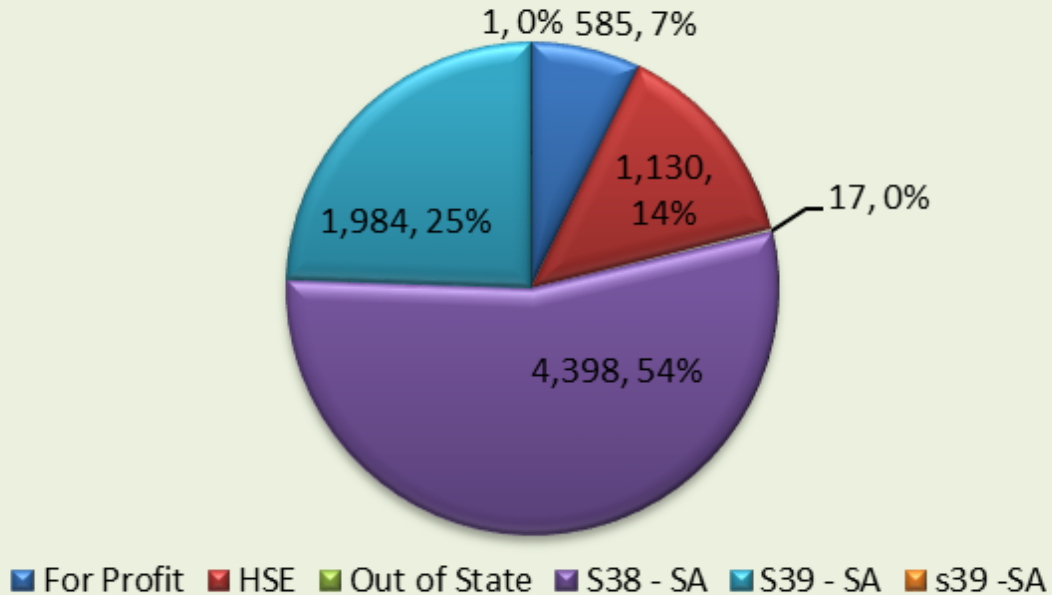
Residential services make up the largest part of the Disability funding disbursed by the HSE – over 60% of the total budget of €2.05 billion in 2020.

Approximately 90 service providers provide residential services to over 8,000 individuals throughout the country. The bulk of these are provided by the 50 highest funded agencies (comprising both Section 38 & Section 39 organisations) – some 6,300 places, or 75%. The HSE itself provides 1,100 or 14% of the places.

With regard to the number and name of all private providers of disability residential care for the HSE; please see Appendix 1 which is a list in alphabetical order of Private Providers of Residential Services (disability funded only). Please note that the list given does not include co funded Private Providers (disability funded and Mental Health or Older Persons Services or Tusla).

As can be seen from the graph below, as at 31st March 2021, 585 residential places are provided by Private For-Profit Providers, which is approximately 7% of the total. It is important to note that these are approximate figures as retrospective adjustments to information provided can be made at a later stage during the year.

With regard to the estimated full cost of funding to all private providers of disability residential care contracted by the HSE in 2018, 2019 and 2020 excluding nursing home care for the elderly, the table below provides the funding to Residential Services since 2018.

Residential Services	1,111,110	1,185,355	1,254,923

As outlined above, Private For-Profit Providers (Disability funded only) account for approximately 7% of residential places provided on an annual basis. HSE provided services account for approximately 14% of residential places provided on an annual basis.
