'To ask the Minister for Health the whole-time equivalent approved posts for consultant anaesthetists at each location; the number filled and vacant; the basis on which they are filled; and if he will make a statement on the matter'

Dear Deputy Cullinane

The data contained in this response is extracted from DIME (Doctors Integrated Management E-system) as at 27.04.2021.

DIME is dependent on clinical sites inputting details on their Consultant workforce and therefore there may be variances and gaps in the data supplied to that held within clinical sites. As DIME is a live system it must be noted that there can be variances in the figures published dependent on the run date of the report as entries can be made with a retrospective date

Data on Consultant staffing can only be reported by post(s), rather than WTE. The figures in table 1 below relate to CAAC (Consultant Applications Advisory Committee) approved Consultant posts. To note: there are a further two Consultants employed on a Temporary basis but due to GDPR this would be providing personal information. For that reason, these two posts have been omitted from the below total figures.

Definition of Status

- **Filled** The clinical site has verified that a Consultant currently occupies this post
- Vacant The clinical site has verified on DIME that this is a vacant post, however, it should be noted that recruitment for the post may be underway and in some cases appointments may have already been made with a prospective start date
- **Unknown** The clinical site has not yet assigned a Consultant to the post or marked the post as vacant

It should be noted that 2021 has seen a surge in the number of posts being approved by the CAAC, and this has resulted in a higher number of vacancies. There is often a significant period of time between approval of a consultant post to an appointee commencing employment. The most recent CAAC meeting was just held on Tuesday 13th April 2021.

The following should be noted in relation to the tenures provided above:

- **Permanent** includes Consultants appointed on a permanent basis and Consultants who have obtained a contract of indefinite duration.
- **Temporary** incudes fixed term contract holders, specified purposes contract holders and Consultants engaged via Agency.

Temporary Consultants includes those who are appointed for reasons such as maternity leave, career break, sick leave etc. or to backfill permanent Consultants who may be seconded to another role e.g. clinical lead, clinical director etc., as well as to fill vacancies.

In some instances, there may be more than one consultant assigned to a Consultant post for a variety of reasons (job-sharing, locums etc.). The tenure is determined by the Consultant that was most recently assigned to the post.
