**20005/21 - To ask the Minister for Health the number of beds in acute mental health wards that are occupied by persons with neurological disorders waiting to access long-term care. -Donnchadh Ó Laoghaire”**

Dear Deputy Ó Laoghaire,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

The HSE does not collate data by mental health diagnosis, should we do the HSE will make this available.

As the body responsible for implementing most of the recommendations in *Sharing the Vision*, the HSE are in the process of establishing an appropriate structure with managerial, clinical and operational representation to ensure delivery of its actions on an ongoing basis. The purpose of the HSE Implementation Group is to provide strategic advice, leadership, and guidance for developing and implementing evidence-based approaches to priority actions described in *Sharing the Vision*. The policy recommends examining current acute bed provision for those with complex mental health needs as a priority. One of the main priorities identified in the policy is to establish a working group to examine bed capacity in Ireland and consider the nature of mental health service provision for the population. The group is expected to explore international research to develop targeted service development plans that address bed occupancy and provision.

In 2021, additional funding of 5M Euros for COVID emergency bed purchase in Private hospitals is in place, and an extra 6.75 M Euros for ongoing purchase of external beds/long term care. An oversight group has been established to progress this work. To date, HSE MH, in conjunction with HOS MH and ECDs, has undertaken a review of Approved Centres in our 9 CHOS and CMH to identify individuals with a longer-term care need. The oversight group has completed engagements with several service providers, and a tendering process is underway.
