The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response.

In response to the status red severe weather warning alert issued by Met Éireann on 6th December 2021 Cork Kerry Community Healthcare (CKCH) activated its business continuity procedures in line with the HSE Severe Weather Planning Guidance for HSE Services, September 2017, for responding to a severe weather event across its services.

For the duration of the severe weather alert Emergency Management Team Meetings were held at Regional, Community Healthcare Organisational, and local Management Team level as outlined below:

In addition to the above meetings, each of the CKCH and Estates representatives who were due to appear before the Joint Oireachtas Committee on Health on 7<sup>th</sup> December would have been in constant contact throughout the day with HSE staff, line managers, emergency services, local authorities and other partners to ensure that our detailed contingency plans were in place to ensure the continuity of services at such a critical time. Our priority throughout the weather alert was the safety of our services users and staff, while at the same time minimising the disruption to services. In the immediate aftermath of the alert, our focus was to revert to normal service levels as quickly as possible. In this regard, we thank our staff for the work and planning they undertook to make sure that essential services were maintained and that those using our services were kept safe.
