Dear Deputy Clarke,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Questions (Reference 6411/21 & 6409/21), which you submitted to the Minister for Health for response.

PQ 6411/21 - "To ask the Minister for Health the input surgeons have in the decision-making process of prioritising those suffering from hearing loss for bone anchor hearing aids."

There are currently six acute hospitals that provide the HSE National Bone Anchored Hearing Aid (BAHA) service. Funding for sites is provided centrally through the HSE with an agreed minimum allocation of BAHA devices to each site per year as set out below;

Each service has a small multidisciplinary team that provides assessments, surgery and post-operative management of patients within their catchment area. The National BAHA working group has developed clinical guidelines for referrals, assessment and management of patients. The BAHA team is responsible for prioritising their patients.
