## Capital Submissions - General

34 No. submissions were received. 26 No. were approved for addition to the Capital Plan. Of these 26 No. projects, 23 No. have either received funding or are proposed to receive funding in the 2021 Capital Plan. The remaining 3 No. projects have not yet received funding as they were approved at the NC&PSC meeting of January 2021. These projects will progress following prioritisation and subject to availability of funding. The three projects do not provide any bed capacity. 7 No. projects are under evaluation and will be reviewed further at the next NC&PSC. 1 No. project was not approved. The project does not provide bed capacity.

## Capital Submissions – COVID-19 Emergency Works

230 No. capital submissions were received in relation to COVID-19 emergency capital works. All were approved for inclusion on the Capital Plan. In 2020 €135.5m was provided for these projects. A further €10m is proposed in the 2021 Capital Plan to complete works associated with these projects.

## **Capital Submissions - COVID Works (Restart)**

12 No. were approved for addition to the Capital Plan. Of these 12 No. projects, 10 No. have either received funding or are proposed to receive funding in the 2021 Capital Plan. The remaining 2 No. projects will progress following prioritisation and subject to availability of funding. Neither project provides additional bed capacity.
