## Re PQ: 12520/21

To ask the Minister for Health the funding provided for in the Health Service Executive National Service Plan 2021 to implement new models of care including the provision of wrap-around supports for homeless persons with complex and multiple needs as part of an integrated housing and health policy response in line with the Housing First National Implementation Plan 2018-2021; and if he will make a statement on the matter.

Dear Deputy O'Callaghan,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

The HSE's National Service Plan 2021 includes the provision of wrap-around health supports for Housing First initiatives that are being rolled out and implemented nationally as set out in the National Housing First Implementation Plan 2018 – 2021. This includes physical health, mental health and addiction supports to support the initiative in Community Healthcare Organisations (CHOs).

NSP 2021 funding will be provided to the following Housing First initiatives:
