"To ask the Minister for Health the number of children on the waiting list for pain management treatment at the paediatric chronic pain clinic in CHI, Dublin; the average waiting time for such specialist services; if new referrals for treatment are being accepted by the service; if not, when the service ceased taking new referrals; the steps being taken to address this issue; the reason for the delay in doing same; and if he will make a statement on the matter".

Dear Deputy Ó Cuív,

I refer to your parliamentary question above to which I have been asked to provide a response.

There are currently approximately 85 patients being actively looked after by the complex pain service and over 30 new referrals to the service with a small number of patients waiting up to 12 months.

Children's Health Ireland (CHI) is aware that the current interim situation regarding our Paediatric Complex Pain Management Service is a cause of much anxiety and upset for parents and children. CHI secured funding from the HSE to develop a Paediatric Complex Pain Management Service and has recruited the following new posts; Occupational Therapist, Psychologist, Physiotherapist and Advance Nurse Practitioner.

Recruitment for a permanent Consultant remains active and is envisioned that this highly specialized position will be filled in 2021.

As an interim measure, while the active consultant recruitment campaign remains underway, CHI has arranged for a Consultant Anaesthesiologist in Northern Ireland, who specializes in both Paediatric and Adult Pain Management, to stand up weekly clinics for CHI at Crumlin and CHI at Temple Street since June 2020.

These weekly complex pain clinics take place in CHI at Connolly Urgent Care Centre and include the full Multidisciplinary Team.
