Dear Deputy Wynne,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for response.

The 16,000 additional staff as committed to in the NSP 2021 relate to all services of the HSE, including Acute, Community and Corporate Services. As of 31st October 2021 6,703 additional staff have been recruited across all services of the HSE, with a further 4,076 profiled to year end 2021.

In addition to the ongoing recruitment for New Development Posts, the normal turnover of staff is also subject to recruitment for replacement. The figure below show the 'Net Gain' as of the 31st October 2021, by CHO Area.

Further additional staff for Community Test & Trace (1,735) and Vaccinators (2,583) have been recruited to date and are recorded centrally. It is anticipated that a portion of these staff will be redeployed into HSE vacancies when decisions are made regarding the future of Covid requirements.
