The Health Service Executive (HSE) has been requested to reply directly to you in the context of the following Parliamentary Question, which was submitted to this Department for response.

PQ: 56237/21

To ask the Minister for Health the number of persons over and under 65 years of age on nursing home support scheme funding waiting lists by CHO in each quarter since quarter 4 2018, in tabular form; the number of those waiting more than 12, 24 and 52 weeks, respectively; and if he will make a statement on the matter.

The detailed response is attached at Appendix 1. Please note that the awaiting funding period for NHSS funding is normally maintained at four weeks. There is therefore no client waiting more than 12, 24 and 52 weeks respectively within the period for which you requested details.

The week ending closest to the end of period was used to generate this data. In December of each year, the HSE normally issues NHSS funding in a batch release during early December to allow for clients to move to a Nursing Home in advance of the Christmas period.
