Dear Deputy Guirke,

The Health Service Executive (HSE) has been requested to reply directly to you in the context of the above Parliamentary Question (PQ 56635/21) which you submitted to the Minister for Health for response.

The HSE Community Audiology service provides hearing assessments and management for infants, children and adult medical card holders.

In response to your query, I wish to advise the information sought is not available in the format requested. Please note that services are provided and managed at the Community Health Organisation (CHO) covering the associated local health offices. The following data is available which I will hope will be of assistance to you in relation to waiting lists for hearing aids.
