To ask the Minister for Health if the latest figures for the number of persons availing of methadone replacement treatment with a breakdown by treatment centre and a further breakdown by time in treatment in each centre will be provided; and if he will make a statement on the matter.

Dear Deputy Shortall,

The Health Service Executive has been requested to reply directly to your above Parliamentary Question which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position:

As of the end of September 2021 the Central Treatment List identifies that there were 10,900 on Methadone Treatment and a further 556 on Buprenorphine based treatments nationally (including within the prison system). This gives a total of 11,456 people in receipt of Opioid Substitute Treatment. It is not possible to break this down by individual treatment centres or GP given the low numbers in some cases however for the Deputy's information Tables 1, 2 and 3 below identifies the total number of people in Methadone Treatment at HSE clinics and General Practitioners per CHO.

The most recent available data for length of time in Methadone Treatment from the Central Treatment List as of 31st of December 2020 is set out in the below table 4. International research evidence highlights that increased length of time in OST is associated with improved treatment outcomes (including reduced use of other opioids and reduced criminal activity) and short-term methadone maintenance treatment is associated with poorer outcomes.
