## PQ Number: 49372/21 PQ Question: To ask the Minister for Health the number and locations of Child and Adolescent Mental Health Service Units that accept admissions out of hours in tabular form – Claire Kerrane

Dear Deputy Kerrane,

The Health Service Executive has been requested to reply directly to you in the context of the above Parliamentary Question, which you submitted to the Minister for Health for response. I have examined the matter and the following outlines the position.

## **CAMHS Inpatient Services**

Currently, there are 72 Inpatient CAMHS beds available in four units across the country.

These beds are available for use by all CHO's. A further 20 beds will be provided at the new Children's Hospital, which will include 8 Specialist Eating Disorder Beds. 10 additional Forensic CAMHS beds will be provided in the new National Forensic Facility currently under construction in Portrane, which will bring the total number of beds to 102.

Linn Dara and Merlin Park accept out of hours and weekend admissions. Eist Linn which covers CHO4 and CHO5 facilitates arranged out of hours admissions. One such admission took place during 2020 and two admissions have occurred to date in 2021.
