PQ 50337/21: To ask the Minister for Health if he will provide a schedule of the amounts directly collected by all HSE hospitals and primary care centres in respect of car parking charges for visitors and patients in 2019, 2020 and to date in 2021; if he will also provide the amounts collected by contracted companies to run and manage car parking facilities at HSE hospitals and primary care centres for the same time period; and if he will provide the dividend received by the HSE from private car parking management companies in respect of car parking at HSE sites in 2019, 2020 and to date in 2021.

Dear Deputy Murphy,

I refer to the above Parliamentary Question which the Minister for Health has referred to the Health Service Executive for direct response.

The majority of acute hospitals around the country charge for parking at this stage, with nine acute hospitals providing free parking. The HSE does not have a single contract to provide parking services at all hospitals, instead each hospital has its own arrangements, which reflect their particular circumstances. Data collected as part of the Hospital Car Parking Review in 2018 showed that sixteen hospitals use a third party provider to manage their car parks although the car parks may still owned by the Hospital. Some hospitals may have a third party to service parking meters, entry & exit barriers and security.

As you will be aware, there are three different types of hospital provision in Ireland:

- Health Service Executive (HSE) Statutory hospitals, owned and funded by the HSE.
- Voluntary public hospitals, most of whose income comes from State funds.
- Private hospitals

Income data is centrally available for HSE Statutory Hospitals only – accordingly the attached table provides the income generated from car parking in 2019 and 2020 for HSE Statutory Hospitals. Details for 2021 are not yet available. It also provides details, as per Hospital Car Parking Review, of car parks that are managed by a third party provider.

With regards to Primary Care centres, we are advised by the National Finance Division that, as car parking income from Primary Care Centres represents less than 1% of the overall Car Parking Income recorded by the HSE, it is only available at a total level as the breakdown by each centre is not captured as part of the annual HSE Financial Statements process. In 2019, this figure was \in 82,358 and in 2020 it was \in 29,444. I wish to advise that information in relation to contracted companies for primary care centre car parks is not available centrally.
