Question: To ask the Minister for Health if he will report on the contact tracing which is currently taking place for Covid-19 cases; and the main findings in respect of the key settings in which transmission is taking place.

Dear Deputy Shortall,

I refer to the above Parliamentary Question which has been referred by the Minister for Health to the Health Service Executive for direct response.

In Autumn 2020, the HSE's Test & Trace Programme committed that the Contact Management Programme (CMP) would work to build a sustainable contact tracing service with a dedicated workforce to meet a demand of 1,500 daily cases and 6,000 close contacts (i.e. standing capacity). The HSE's CMP workforce is now highly skilled and agile, and the ongoing programme of IT developments has supported and delivered further efficiencies across the contact tracing system which includes the List your Contacts portal and the Request a Test portal.

The CMP has witnessed a sudden surge for its services throughout the month of October. To put it into context, between October 1^{st} -7th, the CMP received an average of 1,347 positive test results per day from the laboratories. This figure doubled between October $25^{th} - 31^{st}$ to 2,697 per day and has further increased since that date.

With the continued easing of restrictions, and as sectors of the economy re-open, it is only natural that people begin to interact more within the community. Despite this, the average number of close contacts reported by index cases has remained consistent at approximately 2.3 throughout October.

In relation to the to key settings where transmission is taking place, The Health Protection Surveillance Centre (HPSC) publish a weekly COVID-19 outbreak report which includes the key settings where transmission of COVID-19 has been identified. I have included below the link to the recent reports for your information:

https://www.hpsc.ie/a-z/respiratory/coronavirus/novelcoronavirus/surveillance/covid-19outbreaksclustersinireland/ The data extracted from our infectious disease system (CIDR) on November 2nd 2021, reported there were 2,966 COVID-19 outbreaks notified from 21st June 2021 to October 30th 2021 (weeks 26-43, wave 4). In the attached Appendix, Table 1 outlines the most frequently occurring outbreak categories and associated case numbers reported. The eight main outbreak locations presented in Table 1 account for 50% of all notified outbreaks and 60% of COVID-19 cases linked to outbreaks in wave 4. Table 2 outlines the number of outbreaks and associated cases by outbreak category and week of notification.

It is important to note that outbreaks in certain categories are more difficult to identify e.g. outbreaks in the retail sector are confined to outbreaks among staff. In addition, due to the current volume of cases, Public Health colleagues are prioritising certain categories of outbreaks including healthcare settings, special education settings and outbreaks in other vulnerable groups. Therefore, there may be under-reporting in some other outbreak categories.

I trust this information is of assistance.
