## National Doctors Training and Planning (NDTP) Response

The data contained in this response is extracted from DIME (Doctors Integrated Management E-system) as at 04 May 2021. The cyber-attack in May 2021 has resulted in a significant data backlog and it is not yet possible to provide data after May 2021.

DIME is dependent on clinical sites inputting details on their Consultant workforce and therefore there may be variances and gaps in the data supplied to that held within clinical sites. As DIME is a live system it must be noted that there can be variances in the figures published dependent on the run date of the report as entries can be made with a retrospective date

## **Definition of Status**

- Filled The clinical site has verified that a Consultant currently occupies this post
- Vacant The clinical site has verified on DIME that this is a vacant post, however, it should be noted that recruitment for the post may be underway and in some cases appointments may have already been made with a prospective start date
- Unknown The clinical site has not yet assigned a Consultant to the post or marked the post as
  vacant

It should be noted that 2021 has seen a surge in the number of posts being approved by the CAAC, and this has resulted in a higher number of vacancies. There is often a significant period of time between approval of a consultant post to an appointee commencing employment.
