The National Ambulance Service (NAS) has been requested to reply directly to you in the context of the above submitted Parliamentary Questions, which you submitted to the Minister for Health for response.

It should be noted that all NAS resources are dynamically deployed to calls across the country on a nearest available (to the incident) basis and not on a county boundary basis.

The NAS are currently facing delays in responding to ambulance calls across a number of areas nationally. There are a number of factors contributing to this such as a significant increase in activity, increased arrival to hand-over delays at Emergency Departments, elongated call duration due to infection prevention and control measures required due to the current COVID-19 pandemic.

The NAS are implementing plans to improve this situation, however this may be challenging coming into the winter months.
