I refer to your recent correspondence in relation to the above. The Health Service Executive has been requested to reply directly to you in the context of the above Question, I have examined the matter and the following tables outline the position for Mental Health Service CHO1.

The HSE Child & Adolescent Mental Health Services (CAMHS) provide mental health services to Children up to the age of 18 years, who have moderate to severe mental health disorders that require the input of a Multi-Disciplinary Team (as per CAMHS Operational Guideline 2nd ed. June 2019)

Sligo Leitrim CAMHS are members of the CHO1 CAMHS Service Improvement Programme and have also established their own local CAMHS Service Improvement Group. Service improvements have been achieved throughout 2021 with the overall waiting list for children and adolescents waiting for an initial assessment reducing significantly. Work is on-going in sustaining and improving service delivery and a CHO1 submission was submitted in December 2021 to the national CAMHS wait list initiative fund, to support the further reduction in waiting list numbers which resulted in 3 out of the 9 CHO's received approval to proceed with their proposals.

I am happy to confirm that the CHO1 proposal has been accepted, with approval granted for once-off funding in Sligo/Leitrim as follows:
