To ask the Minister for Health the number of medical consultants employed by the HSE who are permanent, who became permanent as a result of holding locum posts in hospitals for a number of years and who are not allowed to register on the Medical Council specialist register; and if he will make a statement on the matter.

National Doctors Training and Planning (NDTP) Response

The data contained in this response is extracted from DIME (Doctors Integrated Management E-system) as at 03 May 2022. DIME is dependent on clinical sites inputting details on their consultant workforce and therefore there may be variances and gaps in the data supplied to that held within clinical sites. As DIME is a live system it must be noted that there can be variances in the figures published dependent on the run date of the report as entries can be made with a retrospective date.

The information in DIME provides the status of a consultant's tenure at any one point in time. The functionality does not exist to record what their previous tenure was before taking up their current permanency.

The qualifications specified by the HSE require that consultants be registered as Specialist on the Specialist Division of the Register of Medical Practitioners maintained by the Medical Council in Ireland in the relevant specialty. Doctors can apply, through one of the many available routes by the Medical Council, to the Specialist Register at any point in time.

Definitions of Status			
Filled	The clinical site has verified that a Consultant currently occupies this post.		
Vacant	Recruitment for the post may be underway but the clinical site has verified on DIME that this is currently a vacant post. An appointment may have been made to a number of these vacancies with a prospective start date. It should be noted that there is often a significant period of time between approval of a consultant post through CAAC to the commencement of the recruitment process and ultimately the recruitment of a Consultant to a post. The vacancy figure includes a combination of posts that have previously been filled but have become vacant and posts that have never been filled.		
Posts filled but not approved by CAAC	There are a number of posts which have not been regulated by CAAC. This can be for a number reasons which include short-term service demands or the site has not yet submitted an application to CAAC.
