Dear Deputy Tully,

The Health Service Executive has been requested to reply directly to you in the context of the following parliamentary questions, which were submitted to this department for response.

PQ: 20250/22

To ask the Minister for Health the estimated cost of establishing two specialist centre-based respite services for children with complex support needs which is contained within the HSE Service Plan 2022; and if he will make a statement on the matter.

PQ: 20251/22

To ask the Minister for Health the estimated cost of establishing a specialist centre-based respite service for children with Prader-Willi syndrome which is contained within the HSE Service Plan 2022; and if he will make a statement on the matter.

PQ: 20252/22

To ask the Minister for Health the estimated cost of establishing seven additional centre-based respite services for children and adults with a disability which is contained within the HSE Service Plan 2022; and if he will make a statement on the matter.

PQ: 20253/22

To ask the Minister for Health the timeframe for the delivery of the ten additional centre-based respite services contained within the HSE Service Plan 2022; the location for each of these centres in tabular form; and if he will make a statement on the matter.

PQ: 20254/22

To ask the Minister for Health the average cost for an intensive respite support package for a disabled child; the average cost of an intensive respite support package for a disabled adult; and if he will make a statement on the matter.

PQ: 20255/22

To ask the Minister for Health the number of intensive respite support packages that were applied for in each of the past five years; the number of intensive respite support packages that were delivered in each of the



past five years; the average cost of delivering an intensive respite support package in each of the past five years, in tabular form; and if he will make a statement on the matter.

PQ: 20455/22

To ask the Minister for Health the types of non-centre-based respite services in use here; the budget allocated to non-centre-based respite services; the funding spent on non-centre-based respite services in each of the past five years in tabular form; and if he will make a statement on the matter.

HSE Response

The HSE and its funded Agencies provide respite care to children and adults with disabilities. Respite can occur in a variety of settings for various lengths of time, depending on the needs of the individual service user and their family or carer, and according to available resources. Respite is not always centre-based and can be provided in a number of ways, e.g. Centre based; In-Home; Home-to-Home; Family Support, etc. As a vital part of the continuum of services for families, respite potentially helps prevent out-of-home full-time residential placements, preserves the family unit, and supports family stability.

The HSE is very much aware of the importance of respite service provision for the families of both children and adults with disabilities and the impact the absence of respite service provision can have on other services being delivered.

Unmet Need and growing demand

The provision of residential respite services has come under increasing pressure in the past couple of years due to a number of impacting factors such as,

- an increase in the number of children and adults who are seeking access to respite as a reflection of general population increase;
- increasing levels of complexity across the sector due to better and improved health care;



 an increase in the age of people with a disability resulting in people presenting with "changing needs".

In addition, a significant number of respite beds have been utilised for long term residential placements due to the presenting complexity of the individual with a disability and also due to home circumstances, therefore, the numbers of people with disabilities in receipt of residential respite services and the corresponding number of respite nights has reduced when compared to previous activity.

A further impact to the delivery of respite has been in response to the regulation of service provision as set by the Health Information and Quality Authority regulatory and policy context. HIQA has established and set the way in which residential/respite services is provided requiring the Agencies comply with regulatory standards in order to meet regulation. Standards specify a requirement for personal and appropriate space impacting on the capacity and Statement of Purpose for a Designated Centre. This has had a direct impact on capacity where respite beds are no longer allowed within a residential setting e.g. vacated by residents who go home at weekends or for holidays, can no longer be used for respite. Implementation of the national policy on congregated settings (Time to Move on from Congregated Settings Policy) is also affecting capacity.

In 2021, while services were operational in all areas, there was reduced capacity due to the ongoing pandemic and necessary infection prevention and control requirements. Nevertheless, the number of respite overnights operated at (94,606), 10.9% ahead of the target for the year of 85,336, which is reflective of the easing of restrictions during the second half of 2021. The number of day only sessions operated at (16,306), -22.2% below the target of 20,958 for 2021. This was mainly due to necessary precautions to maintain physical distancing and to adhere to infection prevention and control, as would be the case in day service provision. A further reason for the reduced number would have been the shift toward alternative forms of respite (i.e. preference for in-home supports). In addition, Day Respite typically accommodates larger groups than overnight respite and often takes place in a day centre in the evening and on Saturdays (especially for children), therefore, the effect of covid measures and physical distancing has significantly reduced capacity, particularly where services are working to the same staffing.

Funding

The manner in which funding is allocated/distributed allows for a distinction between broad categories of funding such as services for Older People, Primary Care and Disabilities in general. Disability services are provided based on the needs of an individual rather than by the actual type of disability or service required. In this context, as respite services are provided according to each person's individual unique needs and set of circumstances, information on average costs for respite services and intensive respite support packages is not available. Respite costs for centre based and non-centre based are not collated separately.

However, we can say that in 2020, funding allocated to respite services amounted to approximately €70 million and represents about 3% of total funding. This would be similar for previous years.

While this funding is not routinely collated and aggregated into a statistical profile, in 2018, the Minister for Health announced an additional €10 million for the HSE, specifically to enhance respite care in the disability sector. In accordance with the National Service Plan for 2018, the HSE committed to providing:

- An additional respite house in each of the nine CHO areas which will support 450 individuals in a full year and 251 in 2018 (€5m).
- Three additional respite houses in the greater Dublin areas (CHOs 7, 8 and 9) to support a further 225 individuals in a full year and 143 in 2018 (€3m).
- Alternative models of respite to support 250 individuals with disability (€2m).

The funding provided for the equivalent of 12 new houses, 1 in each CHO, and 3 in the Greater Dublin area. This resulted in an additional 6,455 bed nights delivered to 763 people.

Alternative respite in the form of summer camps, evening and Saturday clubs were also put in place, benefiting hundreds of adults and children. Community-Based, alternative respite projects delivered 15,144 'in home' Respite Hours, to 400 users and 1,296 Saturday/Evening/Holiday Club 'sessions' to 1,500 people.



2021 Developments

The need for increased respite facilities is acknowledged and the HSE continues to work with agencies to explore various ways of responding to this need. In accordance with the National Service Plan 2021, the HSE is endeavouring to provide nine additional centre-based respite services, providing some 10,400 additional respite nights along with a range of alternative respite projects including Saturday clubs, breakaway schemes, and summer schemes. Most of these are already in place and the remainder will be in place by second quarter of 2022.

2022 Developments

In accordance with the NSP 2022, the key priority areas in relation to Respite Services for people with disabilities and their families are:

- Establish three additional specialist centre-based services to provide 4,032 nights to 90 children, one
 to be Prader-Willi appropriate and the other two to provide high-support respite for children and
 young adults with complex support needs, in addition to seven further respite services which will
 provide 9,408 nights to 245 children and adults in a full year.
- Provide additional intensive respite support packages to children and young adults.

This is a key priority area for the HSE in relation to Respite Services for people with disabilities and their families and follows on from the significant investment in respite services in 2021.

Currently each CHO is working to implement these developments, including tendering where necessary, identifying appropriate facilities, recruiting staff and securing registration with HIQA. This work will influence the location and timeframe for the delivery of the ten additional centre-based respite services in all of the nine Community Healthcare Areas.

Proposed estimated costs for a Prader Willi-appropriate respite service is approximately €65,000. A specialist respite service for children with complex medical needs is estimated at approximately €1.2m each. A planned respite service is estimated at €600,000 each. Intensive home respite support packages are estimated to be on average at €25,000 per package.

Intensive Respite Support Packages

With regard to the number of intensive respite support packages that were applied for in each of the past five years, this information is not collated nationally. Applications are made to the local CHO areas.

With regard to the number of intensive respite support packages that were delivered in each of the past five years, these respite packages have not been distinguished from other types of support packages. The development of Intensive Support Packages was a new initiative put in place in 2020 and then further developed in 2021. The rationale behind the initiative was to demonstrate a person-centred approach to targeted supports designed to maintain the person in their own home and community, reducing a risk of future residential needs.

These intensive transitional support packages, mainly aimed at children and young people with complex/high support needs experiencing substantial levels of need, but who do not, as yet, require a high cost long term residential placement. The intention being to prevent family breakdown and demand for emergency residential placements by providing access to pre-crisis inventions such as:

- Intensive in-home visiting supports;
- Planned residential respite interventions;
- Specialist behavioural support interventions;
- Access to planned extended day / weekend and summer day based activities.



In 2020, Disability Services committed to provide 144 intensive transitional support packages. However, at end of December 2020, a total of 857 intensive home support packages were developed across the 9 CHOs. Similarly, in 2021, Disability Services committed to developing 358 additional intensive support packages and by year end had put in place 437 packages. The significant increase on the NSP targets was thought to be indicative of the requirement for additional in-home services to compensate for the reduction in the delivery of traditional respite services as a result of the COVID-19 pandemic.

Respite Centres

The table in Appendix 1 provides a list of Respite Centres catering for adults and children throughout the nine CHO Areas, taken from the HIQA Register of Disability Designated Centres. It should be noted that in most respite centres, the occupancy levels as reported to HIQA represents the maximum number of children and adults that could attend the centre at any one time. However, operationally, the actual occupancy levels would generally be lower than the maximum due to the complexities of the people that would routinely be catered for. In addition, occupancy levels have been significantly impacted by the onset of the COVID-19 pandemic.

It is not possible to provide information regarding centres specialising in different types of disability as Disability services are provided according to the needs and requirements of the individual service users.
